

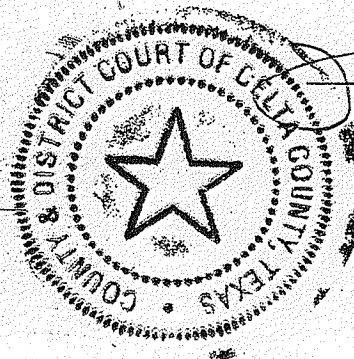

Dear Judge Murray:

I am pleased to inform you that the Texas Indigent Defense Commission has awarded Delta County a formula grant in the amount of \$8,800. The **FY22 Formula Grant Statement of Grant Award** is attached. The resolution adopted by the Commissioners Court and submitted with the application is considered your county's acceptance of the grant terms.

Formula Grant awards less than \$25,000 will be disbursed in a single payment instead of quarterly payments. Please note that Delta County's FY22 Formula Grant award will therefore be disbursed in a single payment in May 2022.

The Commission works together with counties to promote innovation and improvement in indigent defense systems statewide. 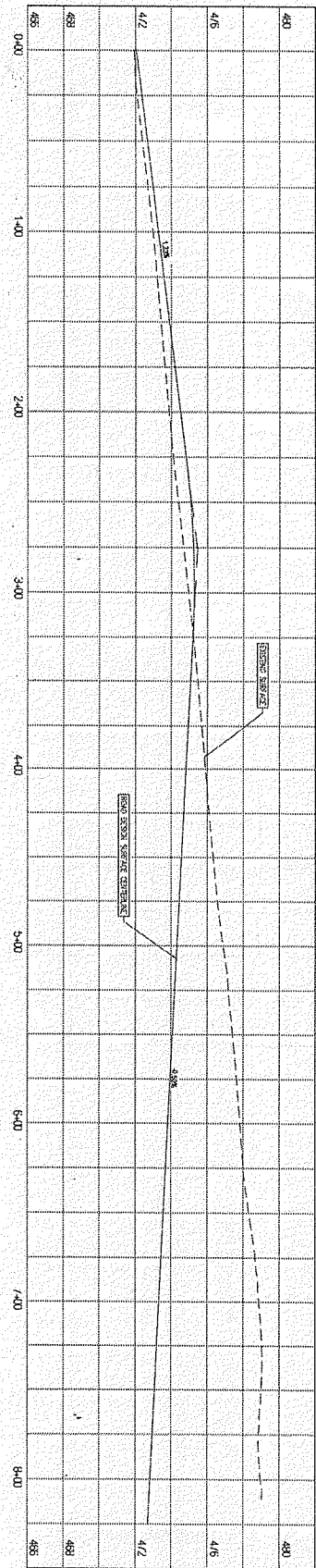

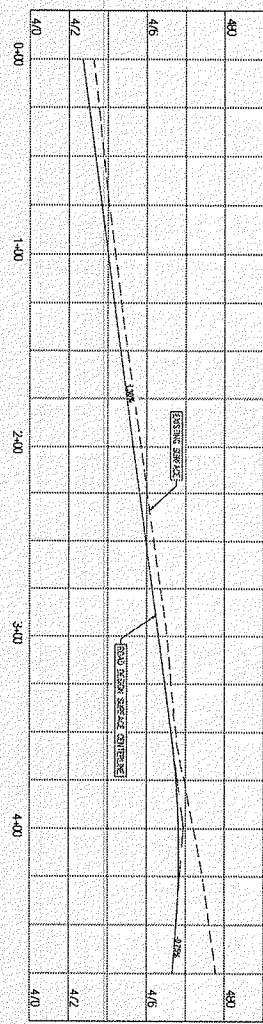
